SHOW HALL: The Craig Center Rock County 4-H Fairgrounds, 1301 Craig, Janesville, WI 53545

SHOW HOTEL: Baymont Inn - 616 Midland Rd., Janesville, WI (608)758-4545, rate \$60.00 plus tax, no pet deposit

AIRPORT: Madison, O'Hare is approx. 1 1/2 hours away.

SHOW HOURS: Check in on Sun. from 7:30am-8:30am. Show hours 9am-5pm. All cats must remain in show hall during scheduled show hours, unless permission to leave is obtained from show management.

SHOW RULES: TICA Show rules will be strictly enforced. By entering, all exhibitors agree to abide by the decisions of the judges and show committee. Official show rules may be obtained from TICA for \$7.00 (TICA, P.O. Box 2684, Harlingen, TX 78551). All kittens entered for competition must be at least 4 but less than 8 calendar months old on the day of the show. Kittens may be spayed or neutered. All kittens for sale must be at least 3 months old. Household pets over 8 months MUST be spayed or neutered. No kitten/cat may be placed underneath the benching area. No kitten/cat may be left in the show hall over night. Leaving the show hall early without permission of the show manager may result in loss of finals. No sales cages without an entry.

HEALTH REQUIREMENTS: This is a non vetted show. Cats showing signs of earmites, fleas, fungus or any illness will not be permitted in the show hall. All entries should be immunized against feline rhinotracheitis, calici virus and feline enteritis and should test negative for feline leukemia and feline aids. Any cat or kitten from a house or cattery where there has been fungus or any contagious illness within 21 days before the opening date of the show is ineligible for entry and or exhibition. Any cat that is obviously pregnant or lactating will be disqualified. All claws must be clipped before judging. Declawed cats are eligible for entry.

SHOW SERVICES: Single benching cages are approximately 22"x22"x22". A single cage will be provided for each entry. All cages must be covered on three sides. For your cats comfort we recommend that you provide a rug and top cover as well. All cats and kittens present in the show hall must have an assigned cage. No more than 2 kittens or 1 adult cat will be allowed per single cage. No kittens or cats may be confined to carriers either displayed or under cages during show hours. Any person disregarding this rule will be asked to leave the show hall. Litter will be provided. Please bring your own litter pan, food and water bowls.

AWARDS: Rosettes will be awarded according to TICA Show rules.

FOR THE COMFORT OF OUR EXHIBITORS AND SPECTATORS: The show hall is a nonsmoking building. Children are always welcome at our show but must be supervised at all times. Show management reserves the right to ask parents to control or remove disruptive children.

LIABILITY: Neither Midwest Norwegian Forest Cat Club, TICA, DuPage County Fairgrounds or Super 8 Motel can be held liable for loss theft or accident to cats, kittens, personal property, exhibitors or their guest.
